# TERMS & CONDITIONS

Please read the following terms and conditions.

A non-refundable deposit of £50.00 is required at the time of booking, with the balance due 28 days before the event. Please make the deposit cheque payable to Alison Mail, and the rest of the payment will be required in cash.

On receipt of the completed booking form and the deposit being paid, the booking will be confirmed with a copy of the agreement sent to the client stating all the details of the booking and the final costs of the booking. On agreeing all details as stated, one copy requires the client signature before returning it to:

The booking is only for the date specified, if amendments to the date or venue are required, subject to availability, a new booking agreement will be drawn up specifying the changes.

If, in the unlikely event, the client wishes to cancel the booking more than four weeks prior to the event, other than the non-refundable deposit no further charges will be payable. If cancellation is less than four weeks but more than fourteen days prior to the event then 50% of the outstanding balance becomes payable. Should cancellation occur less than fourteen days prior to the event, the outstanding balance becomes payable.

# TERMS & CONDITIONS

To understand the terms under which we are doing business, we are obliged to set out the following terms and conditions between us.

## Definitions

- Seller** - means, Simply Scrumptious
- Buyer** - means you, the person who is hiring the service from us, even if hiring for a 3<sup>rd</sup> party.
- Delivery Charge** - means a charge that is payable by you to us, for the delivery of the item/service.
- Fountain** - means Chocolate Fountain

## General Booking Terms

A booking is made, and a contract formed, when the Seller receives, from the Buyer, a booking form along with a non-returnable deposit of £50, and we confirm that booking to you. The booking form must be filled in correctly and supplied to us within 14 days. Once the Seller has received the booking form from the Buyer, the Seller will confirm your booking along with an invoice for the balance payment, which must be paid at least 28 days before the booking date. A final reminder invoice will be sent 31 days prior to the event. If you do not pay the balance by the due date the Seller will be entitled to regard the booking as cancelled and no refund will be payable. The Seller will not take responsibility for any delay in reaching any venue due to road works, traffic chaos or any other highway hazard. Any variations on the terms and conditions can only be permitted if expressed in writing by the seller.

## Full Hire

The Buyer hires the fountain on a 'full hire' basis, and agrees to be responsible for any claim against the Seller for chocolate spillage on any item of clothing, furniture, carpets or anything else by others, how so ever caused. The Buyer agrees to provide a 13 amp power supply and parking.

# CANCELLATION

The Buyer must make cancellations in writing. All deposits are non returnable. If the booking is cancelled 28-14 days before the event the hirer will refund 50% of the **balance payment** (if full payment has been made at that time). If the event is cancelled 14 days or less before the event, the hirer will refund 10% of the **total booking price**.

## Breakdown

In the unlikely event that the fountain should breakdown, or fail to operate as a cascading fountain, the system will still allow the guests to dip food into the bowl of the fountain, which will be filled with chocolate, and therefore provide the guests with the experience.

The seller will refund to the buyer 10% of the full hire charge if breakdown occurs.

In any event, the buyer agrees that the maximum claim that could be made in respect of loss or damage is restricted to the total cost of the hire and no more.

## General

The Contract is between the Seller and the Hirer, as principals, and may not be assigned by the Hirer without the express written consent of the Seller. These Conditions form the whole agreement between the Seller and the Hirer and shall not be removed or varied in any way.

The Seller is in default of any of its obligations hereunder. It shall not be liable where such default is due to any act of God, war, strike, lockout, industrial action, fire, flood, drought, tempest or other event beyond the reasonable control of the Seller. In such circumstances, the Seller shall give notice to the Hirer where possible, and be released from performance of its obligations hereunder to the extent the event of supervening impossibility prevents or restricts the Seller's performance.

These Conditions are subject to English Law and the Hirer consents to the exclusive jurisdiction of the English courts in all matters regarding the Services. It is not the intention of the parties to confer any rights contained in The Contracts (Rights of Third Parties) Act 1999 on any third parties referred to herein, and any such rights, which may otherwise be implied, are hereby excluded.
